On Tuesday, September 23, 2014 a Regular Meeting - Riverboat of the Illinois Gaming Board ("Board") was held on the 5th floor at 160 N. LaSalle at the Michael J. Bilandic Building, Chicago, Illinois at 10:19 A.M. Present were the following: Chairman Aaron Jaffe, Members, Michael Holewinski and Lee Gould.

**APPROVAL OF MINUTES – Open Session**

Member Gould moved that **the Board approve the open session minutes of its Regular Meeting of August 21, 2014.** Member Holewinski seconded the motion. The Board approved the motion unanimously by roll call vote.

**OWNER LICENSEE ITEMS:**

- Elgin Riverboat Resorts d/b/a Grand Victoria Casino – Ownership Transfer  
**Member Holewinski moved to waive Rule 105(e) regarding consideration of requests at two separate meetings, and pursuant to Rule 235, move to approve the ownership transfer of Hoinfad Trust #3.** Member Holewinski seconded the motion. The Board approved the motion unanimously by roll call vote.
  
- Southern Illinois Riverboat Casino Cruises, Inc. d/b/a Harrah's Metropolis Casino – Bradley Marx Hirsch – Level One  
**Member Gould moved to approve Bradley Marx Hirsch as a Level One Occupational Licensee at Southern Illinois Riverboat Casino Cruises, Inc. d/b/a Harrah's Metropolis Casino in his position as Senior Vice President and General Manager.** Member Holewinski seconded the motion. The Board approved the motion unanimously by roll call vote.
  
- Hollywood Casino Aurora, Inc. d/b/a Hollywood Casino Aurora – Scott E. Rhoad – Level One

**Regional Operations for Penn National Gaming, Inc.** Member Holewinski seconded the motion. The Board approved the motion unanimously by roll call vote.

The Board approved the motion unanimously by roll call vote.
- Micro Gaming Technologies, Inc. – Scott Allen Winzeler – Key Person  
**Member Gould moved to approve Scott Allen Winzeler as a Key Person of Micro Gaming Technologies, Inc. in his position as Chief Operating Officer.** Member Holewinski seconded the motion. The Board approved the motion unanimously by roll call vote.

- **Member Holewinski moved to find suitable and approve 47 level 2 occupational licenses, and 108 level 3 occupational licenses, and issue notices of denial to Oscar Mendez and Michael Aslinger.** Member Gould seconded the motion. The Board approved the motion unanimously by roll call vote.

- **Member Gould moved to issue Disciplinary Complaints to revoke the occupational licenses of Nikia Peoples, Sean S. Lewis, Brett Porter and Alicia Ferreira, said actions to take effect 21 days from the dates of service of the Complaints unless the licensees file Answers within that time period.** Member Holewinski seconded the motion. The Board approved the motion unanimously by roll call vote.
