Harrah's Metropolis Casino, operating in Metropolis, Illinois, currently contains a two-level barge facility, four level historical riverboat replica and luxury 258 room hotel.

The barge contains a 175 seat-Fresh market Square Buffet, a 98-seat Range Steakhouse, a 50-seat VIP Player lounge, a 50's Diner, administrative space and 163 Slot machines.

The casino vessel, North Star, contains three levels of gaming with the capacity to hold 1650 customers. It provides 29,760 square feet of gaming space and currently offers 979 slot machines and 27 table games. The fourth level is used for administrative offices, an employee break room, a smoking area for our guests and an observation area.

The land facilities include multiple parking areas, a pavilion and Porte-Cochere, hotel, and entertainment center. The hotel and entertainment center are approximately 228,000 square feet. Harrah's Metropolis Casino & Hotel is comprised of 240 standard rooms, 6 suites and 12 junior suites.

The Entertainment Center space is currently under renovation to accommodate the new Casino gaming area. The new gaming area will also bring the addition of a new restaurant, lounge, three new bars and a live entertainment stage to the property. The new Casino will be approximately 24,000 square feet and offer 820 slot machines and 27 table games including a 4 table poker room. The anticipated date of opening is November 19, 2014.

In addition to the tax revenue generated for the local community, Harrah's provides several economic benefits to the surrounding areas. Harrah's actively supports community projects and organizations such as: Rebuilding Together; Superman Festival; Alzheimer's Association; Relay for Life; United Way, Lions Club; Easter Seals; St. Jude Dream Home; Guardian House; Project Hope; school supply drive for area elementary schools and many, many others. Harrah's charitable donation expenditures include cash grants to charitable organizations; sponsorship of charitable programs; in kind donations like food vouchers and hotel stays and donations of goods to charitable organizations.

Harrah's Metropolis Casino had an average number of employees of 535 in 2013. The number of employees as of September 30th, 2014 totaled 549. Approximately 56% of Harrah's Metropolis Casino employees are Illinois Residents.

Harrah's Metropolis Casino has implemented an Affirmative Action/ Equal Opportunity Plan. This plan provides tools for management to comply with federal and state affirmative action guidelines. We continue to employ a high number of females and minorities. Our percentage of females and minorities employed on property is 53% and 16% respectively (as of September 30th, 2014).
