DESCRIPTION OF PROPOSED SPORTS WAGERING OPERATION:

DraftKings at Casino Queen proposes to operate a retail Sports Book at its existing Riverboat facility. DraftKings at Casino Queen proposes a temporary retail location initially in the northeast corner of its existing buffet with a Sports Book lounge, monitors, kiosks, and ticket windows. DraftKings at Casino Queen proposes remodeling of existing venue/s into a permanent retail Sports Book with kiosks, ticket windows, monitors, and multiple food and beverage outlets. DraftKings at Casino Queen intends to enter a contract with a Management Services Provider Licensee to conduct operations.

DESCRIPTION OF APPROVED RIVERBOAT GAMING OPERATION:

DraftKings at Casino Queen's gaming operation sits on approximately 70 acres and consists of a 207,500 square foot moated facility which contains a single level 40,000 square foot casino featuring over 25 table games and almost 1,000 slot & video poker machines, four (4) restaurants, including Prime, a gourmet steakhouse; Sevens, a nightclub/sports bar; the Market Street Buffet and Deli n' Chips, a delicatessen. Other amenities include a players club, administrative offices, service bars and back of house operations. In addition to its casino building, DraftKings at Casino Queen operates a hotel and a RV Park.

DraftKings at Casino Queen's gaming operation is located in East St. Louis, St. Clair

County, Illinois directly across from the Gateway Arch and downtown St. Louis.

With spectacular views of the St. Louis skyline, DraftKings at Casino Queen's hotel features, 157 guest rooms including 7 penthouse suites, 10 Spa King Rooms and 90 rooms overlooking the Gateway Arch and downtown St. Louis. Other hotel amenities include a grand ballroom, a hospitality room, conference space, a board room, an indoor, environmentally controlled swimming pool, and work out facilities.

**ECONOMIC BENEFIT TO THE STATE AND ITS HOST COMMUNITY:**

Since opening its doors in June 1993, the Board of Directors, Management and Staff of DraftKings at Casino Queen have kept in mind that the intent of the Riverboat Gambling Act was to promote economic development in depressed areas and foster tourism for the State of Illinois, and its host community, the City of East St. Louis. With this in mind, each capital expansion plan, marketing plan and or program implemented by the Company has been designed to assure adherence to the economic development and tourism requirements of the Act.

DraftKings at Casino Queen recognizes its responsibility as the cornerstone of economic revival in East St. Louis. Beginning with DraftKings at Casino Queen's initial \$42 million dollar investment in its property, DraftKings at Casino Queen has made significant capital investments to its facilities including a \$96 million state-of-the-art gaming facility, a \$15 million 157 room hotel (the first hotel built in East St. Louis in 40 years), a \$4.6 million RV Park, and a \$2.15 million nightclub/sports bar known as Sevens. DraftKings at Casino Queen has invested over \$200 million in capital improvement projects from 1994 through 2018. These capital improvement projects have brought jobs and economic opportunity to local business demonstrating DraftKings at Casino Queen's commitment to revitalize this once economically deprived community.

DraftKings at Casino Queen's commitment to capital improvement projects allows it to maintain a viable gaming operation. Coupled with easy access from three bridges, surrounding interstates and light rail public transportation, DraftKings at Casino Queen is a vital entertainment destination for the St. Louis Metropolitan area. DraftKings at Casino Queen's property is uniquely situated to promote tourism because of its close proximity to the Gateway Arch, the St. Louis Zoo, Union Station, Busch Stadium, the Scott Trade Center, the St. Louis Convention Center, the Edward Jones Dome, Gateway International Speedway and the National Shrine of Our Lady of the Snows.

Lastly, DraftKings at Casino Queen economically benefits the City of East St. Louis by generating over \$5 million last year in local gaming taxes. The city has used this revenue to bolster its general fund, provide services to its citizens, fund police and fire services and public works projects.

**NUMBER OF EMPLOYEES:**

As of December 31, 2019, DraftKings at Casino Queen employed approximately 467 employees in total at its gambling operation. Sportsbook personnel are actively seeking individual licensures at the time of this disclosure.

**COMPLIANCE WITH AFFIRMATIVE ACTION GUIDELINES:**

DraftKings at Casino Queen complies with all applicable federal and state affirmative action guidelines and it is an equal opportunity employer.
