Harrah's Joliet is located in downtown Joliet, Illinois, on the Des Plaines River. A single-level gaming barge was opened in October 2001. This new facility replaced the Northern and Southern Star vessels and provides a more comfortable and exciting environment. It offers 40,000 square feet of casino space with 33 table games and 1,138 slot machines. The property includes three restaurants, a snack bar, Starbucks, an entertainment bar, three retail shops, a sundry shop and approximately 6,110 square feet of banquet and event space. Parking is available for 1,800 cars, including a four-story parking garage with 580 spaces, a six-story garage with 1,022 spaces, as well as a valet lot with 198 spaces. Hotel facilities include 200 rooms (over 500 square feet each) and four themed suites. The hotel has been averaging occupancy greater than 90% since it opened in November 1999.

In 2012, adjusted gross gaming receipts were \$212.1 million with 1.8 million admissions. As of December 31, 2012, a payroll of \$26.4 million was paid to 961 employees. 2012 Government expenditures as a result of riverboat gaming and admission taxes include neighborhood development, infrastructure development, and municipal development. Harrah's Joliet's charitable contributions include donations of cash and goods to charitable organizations, the purchase of tickets to fundraising events, and sponsorship of charitable programs or scholarships.
