The licensee, Des Plaines Development Limited Partnership, is a Delaware limited partnership, and it has no officers or directors. Its ownership interests are held 20% by Des Plaines Development Holdings, LLC¹, its Limited Partner (pending ownership transfer to JD Holdings, LLC, 100% owned by Jonathan D. Eilian) as approved by the Illinois Gaming Board on September 13, 2018; and 80% by Harrah's Illinois, LLC, its General Partner, which is owned 100% by CEOC, LLC. CEOC, LLC is solely owned and member managed by Caesars Entertainment Corporation.

On January 15, 2015, Caesars Entertainment Corporation's main operating subsidiary, Caesars Entertainment Operating Company, Inc., filed a petition for reorganization under Chapter 11 of the US Bankruptcy Code with the US Bankruptcy Court in the Northern District of Illinois. Des Plaines Development Limited Partnership, as a subsidiary guarantor of the existing debt of Caesars Entertainment Operating Company, Inc., was a participant in the Chapter 11 proceedings. The court approved the plan of reorganization in January 2017 and the parties obtained the necessary approvals to emerge from bankruptcy which was finalized on October 6, 2017.

Caesars Entertainment Corporation ("CEC"), Des Plaines Development Limited Partnership and Harrah's Illinois, LLC filed their federal and state income tax returns and remitted the appropriate taxes on a timely basis since the last annual Disclosure Affidavit was filed.

The Licensee, Des Plaines Development Limited Partnership, is owned by both Harrah's Illinois, LLC (the General Partner) and Des Plaines Development Holding LLC (the Limited Partner). Harrah's Illinois, LLC is owned 100% by CEOC, LLC, which is owned by Caesars Entertainment Corporation.

Caesars is not otherwise aware of any public officials or officers or employees of any unit of government in Illinois, or relatives of said public officials, officers or employees, who have an ownership or financial interest in the company or hold or have any interest in any contractual or service relationship with, an applicant or licensee.

A description of any proposed or approved riverboat gaming operation, including the type of boat, home dock location, expected economic benefit to the community, anticipated or actual number of employees, any statement from an applicant or licensee regarding compliance with federal and State affirmative action guidelines, projected or actual admissions and projected or actual adjusted gross gaming receipts.

Harrah's Joliet is located in downtown Joliet, Illinois, on the Des Plaines River. It offers 39,000 square feet of casino space with 39 table games and 1,086 slot machines. Harrah's property includes four restaurants, a sundry shop and approximately 6,110 square feet of banquet and event space. Parking is available for 1,800 cars, including a four-story parking garage with 580 spaces, a six-story garage with 1,022 spaces as well as a valet lot with 198 spaces. Hotel facilities include 196 rooms, over 500 square feet each and eight themed suites. The hotel has been averaging occupancy greater than 90% since it opened in November 1999.

In 2018, adjusted gross gaming receipts were \$178 million with 1.3 million admissions. As of December 31, 2018, a payroll of \$27 million was paid to 805 employees. 2018 Government expenditures as a result of riverboat gaming and admission taxes include Community and Economic Development (CED), Administrative Services, Fire, Police and Public Works. Harrah's charitable contributions include donations of cash and goods to charitable organizations, the purchase of tickets to fundraising events and sponsorship of charitable programs or scholarships.

Harrah's is actively involved with many community organization projects; such as, the Joliet City Center Partnership, United Way of Will County, Joliet Chamber of Commerce, Will County CED, Responsible Gaming Programs, Project 21 and Operations Bet Smart, American Cancer Society, Senior Services Center, Guardian Angel Home, Meals on Wheels, Big Brothers Big Sisters of Will and Grundy Counties, Easter Seals, Alzheimer's Association, Will County Habitat for Humanity, Miracle League of Joliet, Joliet/Will County Project Acclaim, American Red Cross, Joliet Spanish Community Center and the George Werden Buck Boys and Girls Club of Joliet.

At Harrah's Joliet, as with all other Harrah's properties we are committed to recruiting and hiring minorities. Harrah's aggressively seeks out qualified women and members of recognized minority groups as candidates for employment. We actively seek out minority and woman-owned suppliers.
